General comment:	Studies like this have original and appropriate ideas. However, it still requires clear, easy-to-understand, and complete writing so that the reader knows what is actually being done.
Introduction:	In the introduction, the author continues to present the needs of this study following the environmental issues explored. However, the writer still needs to get the support of previous studies/existing research findings to show that there is a strong rationale for continuing this research project. For example, the sentiment analysis presented - why is there no reference made to help the reader to deepen it? As if what is written is only as far as ideas from researchers. In the literature review 2.1, is sentiment analysis merely an idea/view from the writer only? To what extent are the algorithms described in 2.2 and 2.3 suitable for use in the researcher's ideas? Where is the evidence of previous studies?
Methodology:	The methodology "states" the general architecture but does not explain the "workflow" and how to do it in each work step.
Results:	Surprising how the implementation of Naïve Bayes and LSI is placed under the conclusion? Where are the findings and discussion?
Discussion:	No discussion was detected.
Bibliography/References:	There is still room for improvement to write references systematically and according to the proper format.
Decision:	Readers are not sure if this paper is part of a research paper. However, based on the title of the writing, the author has not yet explained what it should be.



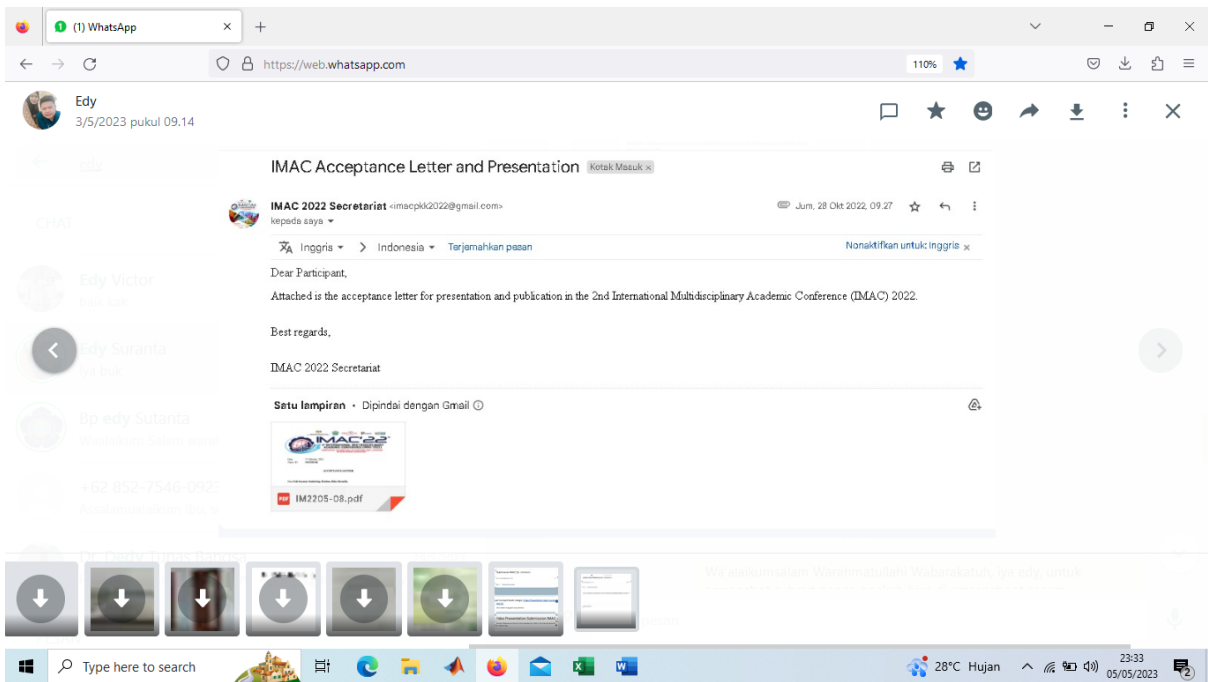
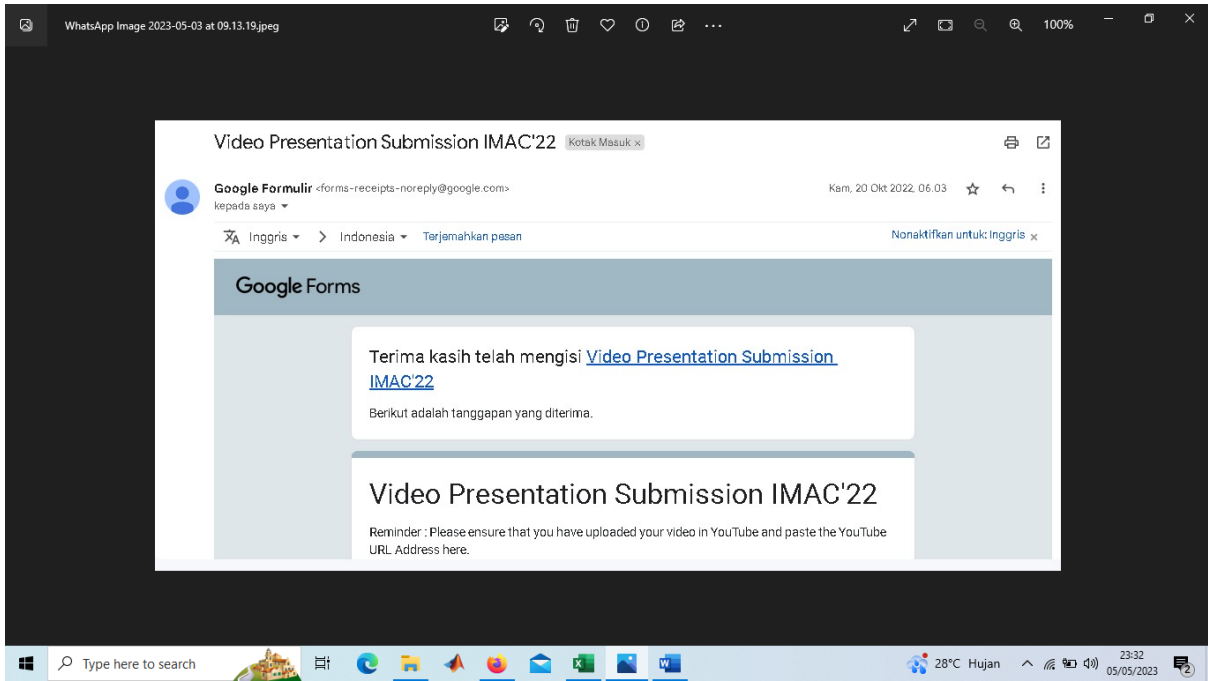
